5. STAFF REPORTS

A. Virtual Community Center

This report provides the Parks, Recreation & Cultural Arts Commission with information regarding the Los Alamitos Recreation and Community Services Department in providing a free Virtual Community Center located online and uploaded weekly with new information, activities, and classes for the community to enjoy

Acting Director of Recreation & Community Services Emeline Noda summarized the staff report.

B. Enrichment Explorers Program

This report provides the Parks, Recreation & Cultural Arts Commission with information regarding the upcoming Enrichment Explorers Program. Starting this September, the Day Camp program plans to transition to an enrichment program to provide support for families during hybrid schooling. Parents working outside the home and working from home indicated the need for childcare with the hybrid school schedule.

C. Preview of September City Events

This report provides the Parks, Recreation & Cultural Arts Commission with a preview of the upcoming September City events. The Los Alamitos Recreation and Community Services Department has modified upcoming events according to COVID-19 restrictions to keep the community as safe as possible, while still being able to enjoy community events.

Acting Director of Recreation & Community Services Emeline Noda summarized the staff report.

6. ITEMS FROM THE RECREATION & COMMUNITY SERVICES DEPARTMENT

Ron Noda, Acting Deputy City Manager

- The City of Los Alamitos is undertaking an Active Transportation Plan (ATP) to improve access, mobility, and safety for non –motorized modes of travel, including walking, bicycling, and riding transit. The first Community Presentation to learn more about the ATP will be via Zoom on September 3, 2020 from 5:30 p.m. – 7:00 p.m.

- A new blueprint for business sector re-opening was unveiled by Governor Newsom on August 28, 2020, which includes a color-coded, tiered system that will be used to measure the COVID-19 spread rate/positive test percentage. Orange County is currently in a blended purple/red tier; and, with our numbers trending in the right direction, is on track to transition to the red tier on September 8, 2020. Counties must remain at each tier for a minimum of 21 days. Up-to-date information is available on the website at www.cityoflosalamitos.org.
- Information on the City of Los Alamitos Measure Y - The Quality of Life, 911 Police Response, Business/Job Protection Measure information is on the City's main webpage.
- The City of Los Alamitos Grocery Program was highlighted in the California Parks & Recreation Official Magazine Summer 2020, featured It's All About You, the City of Los Alamitos who strive to "Create Quality of Life" for its community on a daily basis during COVID. The Recreation Department created a Virtual Community Center filled with free activities, classes, education contents that patrons could enjoy from the comfort of their home. Also began a free drive through weekly grocery distribution with their Senior Grocery Program sponsored by Second Harvest Food Bank and provided groceries to over 2000 households as of June 2020.

Emeline Noda, Acting Director of Recreation & Community Services Department

- The Department Activity Guide for Fall will be available on September 15, and will be up to date and as accurate as possible before it goes live for registrants. Classes for the Fall will begin on September 21, 2020. We will continue to keep you updated on any changes relating to programming and events, in the event restrictions are eased.
- The City of Los Alamitos Recreation and Community Services Department staff designed a new enrichment program similar to day camp programming, weekly options only, similar fees, and maximum registration of 40 participants per week. We are prepared to provide childcare needs, before and after school, and working parent's needs as schools reopen in person classes modified classes and distance learning.

Trini Zenovka, Recreation Department Secretary

- We are continuing to provide our Senior Club Membership with weekly zoom meetings topic discussions and will check on all of our senior registrants and members. We will be offering to our Senior Club Members next Thursday the FIRST Drive-Up Birthday Celebration Ice Cream Social. These celebrations will be on the second Thursday of each month from 1:00 – 1:30 p.m. Each month will be themed to keep them engaged and stay connected.

SUMMARY

This report provides the Parks, Recreation & Cultural Arts Commission with a preview of Recreation fall offerings.

BACKGROUND

The Los Alamitos Recreation and Community Services Department has modified upcoming classes, programs, and events in accordance to COVID-19 restrictions. Guidelines and protocols are set to keep the community as safe as possible and to offer the community quality of life classes, programs, and events.

DISCUSSION

Outdoor/Indoor Classes - Classes are continuing outdoors and virtually in accordance with the latest Public Health guidance. Approximately 115 community members are participating in programming, including youth and adult dance, music, art, and exercise classes, and youth sports. The Community Center is planning to open on Monday, October 5 at limited capacity.



Enrichment Program transformed into Afternoon Rec and will now transition to a new T/TH only class called S.T.A.R. which stands for Science, Technology, Arts and Recreation for kids ages 5-12.

Ready, Set, Go! Preschool Program – Sponsored by Southland Credit Union, the Ready, Set, Go! Preschool Program has approximately 20 students enrolled in the Monday-Friday classes for ages 4 & 5 year olds. Per Center for Disease Control (CDC) guidelines, parents are not allowed in the preschool building and utilize the Lifecubby app to check-in/check-out their child. The Lifecubby app also contains a virtual parent board where the newsletter and curriculum are posted. Parents have provided positive feedback of the preschool program with all the changes per CDC guidelines.



Outdoor Church Rental - Grace Community Church rents the outdoor courtyard space of the Community Center from 8:00 a.m. to noon every Sunday. Currently, there is a maximum capacity for indoor facility use so the outdoor space has served as a good alternative.

Youth Sports – Youth Sports current guidelines restrict practices to clinic style only and no on-site school use is available. Staff is utilizing Little Cottonwood Park as the location for youth sports to occur. Currently, there are nine registrations for the Jr. Superstar, 15 total registrations for the basketball training camp, five registrations for the Jr. Pee Wee Basketball program, and four for the Parent & Me Basketball program. Staff is developing a Monday and Wednesday Sports and Rec for Kids class from 3:30 p.m. to 4:45 p.m. offered at Little Cottonwood Park.



Field Rentals - In order to rent a facility (field and gymnasium), a completed application, a certificate of liability insurance, and endorsement with specific verbiage pertaining to the City of Los Alamitos must be submitted. Due to COVID- 19, it is also required that all field users provides a formal plan of what protocols the organization will implement to ensure the safety of their participants, spectators and coaches based off the current CDC's youth sports training guidelines. No games, tournaments, or scrimmages are currently allowed to occur.

Friday Night Lights Flag Football currently has a permit to utilize Laurel Park on Fridays from 4:00 p.m. - 8:30 p.m. Once all required documentation is submitted, St. Hedwig's Pony Baseball will utilize the field on Mondays from 4:30 p.m. - 6:30 p.m. and AYSO Region 159 will be utilizing the field on Tuesdays and Thursdays from 4:00 p.m. - 8:30 p.m.

Senior Grocery Program, Zoom & Wellness Calls – The Senior Grocery Program continues to serve 160+ seniors each Tuesday at Cottonwood Church. Cottonwood Church provides the host location and additional volunteers to supplement the staff. Each week staff potentially has to bag all produce for the program. The bagging of produce requires a large number of staff and volunteers due to the short time frame from delivery to distribution.

Staff is continuing with weekly online Zoom meetings with the Senior Club and bi-weekly wellness calls to all 280 seniors among all of the City's senior programs. The seniors appreciate staying connected with staff through the COVID-19 Pandemic.

The room will be transformed into the witch sisters’ cottage for the participant to solve a variety of puzzles and brainteasers to make their way out each room to the escape the witches’ lair.
